

# Terms & conditions S/Y Amazon, 2020

# Terms and conditions

These terms and conditions are being send to the tenant upon booking stage and need to be printed, signed and returned to corfu unlimited within one week after booking stage.

#### Booking

A reservation can be made by telephone, social media or mail. Accordingly a booking confirmation form will be send to the tenant which needs to be printed, filled out, signed & returned by mail to corfu unlimited within one week after booking stage, together with the signed terms and conditions document.

The booking is final as soon as corfu unlimited has received the filled out & signed booking confirmation form, the signed terms and conditions document and the first payment.

The tenant who makes the reservation is personally responsible for the fellow travellers who are being signed. Regarding minor travellers corfu unlimited assumes that either the parents or guardians have agreed to their participation.

#### Payment conditions

At booking stage the prepayment is 50% within 14 days after booking; the remaining 50% of the total amount must be paid 6 weeks before departure.

In case of booking within 6 weeks before departure, the full amount has to be paid immediately upon booking confirmation. In case the payment is not made in time, corfu unlimited will send a reminder for payment. In case this will not be followed, corfu unlimited has the right to cancel the booking. In case a prepayment was already made, this is not refundable.

#### **Changes to reservation**

In case the tenant wishes to make a change to his final booking, corfu unlimited will charge an administration fee of  $\in$  50,=

#### Cancellation

In case of cancelling by the tenant up to 6 weeks before departure, 50% of the total amount is being charged. Cancellation within 6 weeks before departure, the full amount (100%) of the agreed payment is being charged. No refund possible. In case of cancellation due to unforeseen circumstances, a personal agreement will be made with the tenant to postpone or cancel the arrangements.

# Website offers

Tenants can never claim website offers made which are dated after his agreement has been concluded.

## Security deposit

When renting the yacht bareboat, a security deposit of  $\leq 1.200$ ,= must be paid upfront. This can be paid by bank transfer before arrival, or in cash upon arrival date, before entering the yacht. In case of damage corfu unlimited will hold the tenant responsible. This can raise up to the maximum of the total amount of the security deposit which is also the "own risk". When the costs of the damage are more then the security deposit, this will be covered by the insurance of the sailing yacht. Our yachts have an all-risk insurance with an own risk part.

The final check of the yacht will be done at the end of the journey. A reimbursement of the full amount will be given to the tenant in case the yacht has been returned in the same condition as he received the yacht. In case of damage to the yacht, its equipment or inventory, the security deposit will not or partly be reimbursed

# Transfer

The transfer from Kerkyra airport to Gouvia Marina is not included in the rental price.

# Check in / out

Unless agreed differently, check in is on the day of arrival as from 17:00 hrs. Return to Gouvia Marina is latest by 18:00 hrs. the evening before check out. By that time the yacht is back at its berth in Gouvia Marina. The final check (as mention in section **security deposit**) will be done by the owner (or someone appointed by the owner) as soon as the yacht is back at its berth. Check out is on the departure day at 09:00 hrs. No later.

In case of bareboat rental there will be a proper and extensive handover of the yacht by the owner (or someone appointed by the owner). After that, the tenant is personally responsible for the yacht. The tenant must have sufficient (technical) knowledge to guarantee the safety of the complete crew and the yacht. The tenant is obliged to inform the crew about the possible dangers on board, such as the use of the anchor, the engine, the exchange of gas bottles, etc.

corfu unlimited will never be hold responsible to injuries which have occurred from actions taken during the period of rental to none of the crew.

## Maritime knowledge

Only tenants with sufficient sailing experience and knowledge will be able to bareboat rent a yacht with corfu unlimited. One needs to possess either the "CWO III kajuitjachtzeilen" certificate; RYA Day Skipper certification or equivalent. Furthermore the tenant needs to have sufficient and proven experience in sailing and anchoring the Mediterranean Sea. In case the tenant does not have the required skills, corfu unlimited has the right to decide for a sailing instructor to join the trip to give the necessary instruction. The additional costs must be paid by the tenant.

#### Personal information

In order to smoothly organise your holiday, the tenant is obliged to inform corfu unlimited about his personal information. This contains not only physical or mental handicaps, but everything which is important for the accomplishment of your journey. For all crew member the following information needs to be provided to corfu unlimited in order to prepare the necessary paperwork for the authorities: full name; address; date of birth and valid passport or ID number. These personal details will be handled confidentially and with care.

## Inventory

The yacht will be transferred to the tenant in a safe and clean condition and with a complete inventory. On board of the yacht an inventory list is available. At the end of the rental period the tenant must deliver the yacht in the same condition as how he received the yacht upon arrival. In case of damages, please see section **security deposit**.

#### Use of toilets

It is not allowed to throw any toilet paper or other (such as sanitary towels/tampons/moisturised toilet paper) inside the toilets. The toilets will immediately be destroyed by trying to flush any of these products. The yacht will be given to tenant with good working toilets.

In case there is any damage to the toilets, due to improper usage, tenant is obliged to pay repair costs of  $\notin$  200,=

#### Use of diesel/petrol

The yacht will come with a full diesel tank and a full petrol tank for the dinghy. The tenant (in both cases: bareboat rental and rental with skipper) is obliged to full up diesel and petrol before returning to the berth of the yacht. The costs for use of diesel/petrol are for the tenant.

#### Sailing with skipper

When sailing with skipper, he has his own cabin and food & drinks for the skipper are being provided by the tenant of the yacht.

#### Going home earlier

In case the tenant needs to leave earlier, this will be seen as a cancellation of the agreement. For more information see section **cancellation** 

#### Repairs to the yacht

In case repairs are needed to the yacht whilst tenant is away from the home base of the yacht, one must understand that it takes time for the repair and/or the delivery of (broken) parts to the yacht. When a serious shortage occurs to the tenant of the ship, complaints will not be dealt with in case the shortage is resolved within 36 hours. It is expected that tenants of the yacht are capable to make small repairs themselves to prevent further damage or discomfort.

In case the tenant of the yacht is unavailable due to technical problems or majeure, corfu unlimited keeps the right to offer an alternative solution.

When the rental costs of an alternative are lower/higher as the original arrangement, the tenant will pay the difference or will get a refund. When the tenant does not accept the alternative offer, he has the right to cancel his booking free of charge within 24 hours after communication with corfu unlimited. In case the tenant has to make additional costs due to this occasion, this can not be claimed from corfu unlimited.

#### **General reservation**

Eventual mistakes can not be claimed. All offers are completely optional.

#### Complaints

corfu unlimited does its utmost to make a success to a fantastic holiday, however, unexpected things can happens or can go wrong. In case of an incident, tenant is obliged to inform corfu unlimited immediately. This way corfu unlimited is been given the opportunity to resolve the problem accordingly. Complaints must be sent within 30 days after the journey.

## Liability

corfu unlimited is never liable to damage, injury, loss or theft which occurs during a stay on one of their sailing yachts. Every tenant or participant to sailing journeys/courses of more than one day, is obliged to have a travel- and injury insurance. We recommend to also have a cancellation insurance.
